### **County Farm**

There is a problem at CF where one gardener has expressed in detail that they are being harassed by another gardener. This has gone on for months. The situation escalated on June 30<sup>th</sup>. At this point this person no longer feels safe to garden at the site & requested that this situation be brought to the board.

There was a lot of discussion about the accused person with others expressing concern about this gardener's behavior.

Royer talked to Germain Smith at Dispute Resolution Center (part of Washtenaw County). They use a process called Restorative Justice. The board decided to move forward with this organization & encourage the concerned parties to work with them.

# **Dispute Resolution Process**

Edit the bylaws to use a service like the Dispute Resolution Center for disputes that escalate beyond the ability of PG to handle. Have the changes ready for the annual meeting for review & possible approval. A committee has been started to work on these. Royer, Daniel, & Marcella volunteered for the committee.

#### **New Sites**

Joet is planning a tour of Vestergaard's site. Lots of ideas of what we may be able to do at the site. Joet volunteered to organize the tour & information gathering with Mike Vestergaard & find out what is opportunities there are for PG.
