# **Managing Director Report** (copied from report)

#### **Board Elections**

An announcement about the board elections was in the September newsletter.

Any other nominations need to be sent to info@ by September 15th. Jesse, Sharon and Bilge need to submit statements by September 20th. We also

have a 3rd opening for Beth. Her term ends next year so it may be easier to handle it as a board appointment. We will assign Beth's position if needed. Calin said if no one is interested, he will continue on the board.

### Gardening Angels

We have a couple people volunteer for this from County Farm, but it is unclear where they need to work and who will oversee it. At this time, we have no one to run the project.

## Hoophouse

Once the weather cools off, I could use help for an hour or two cleaning up the hoop house. I've roughly cleaned up parts of it, pulling out the big weeds for 10 minutes a couple times. Sharon said she would help.

#### Retirement

I will retire as Managing Director in December 2022. I told the personnel committee about this a couple months ago. We talked about me continuing to do the plant sale after 2022 as a paid employee and I plan to do that. We have plenty of time to plan for this.

It has been a wonderful experience working for Project Grow and alongside all of you!

A proposal was made to create a paid intern position for 2022. If possible, we will have someone that's volunteered & worked for PG like a board member for the position. This person will work with Kirk in 2022 & if everything works out, becomes the new Managing Director. Contract Eric if interested.

#### **Outreach Committee**

A final inspection is planned. It's been suggested that a wider group of board members & we had a discussion on it. The inspection will take place Oct 23<sup>rd</sup> & Calin, Joe, Royer & some others did volunteer for it. We will nail down the attendance & time at Oct board meeting.
